

The Net Income of the International Office for 2012 was \$186,439


Total Income for Charitable Projects for 2012 was \$7,729,570 and total disbursements were \$3,615,053.

The following charts give an overview of the total overall income and disbursements for 2012, in addition to a breakdown of unrestricted income and expenses.


FPMT Inc - Overview of Total Income and Disbursements: 2012


